T1-Ash(Fraxinus excelsior)

-remove all overhanging branches to suitable growth points OR main stem collars using rigging to lower branches in a controlled manner where necessary -remove large outbound stem over front area to branch union as discussed -ensure adequate clearance (2m) form building roof by removing selected branches

All work agreed with owner for bird deterrent control measures and reduce potential damage from branch interfering with building gutters etc
