e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in the same place.

T1-Ash-rear-To contain spread and to improve light into garden.Suggest: Reduce back to previous reduction points, retaining furnishing growth where possible. Pigeons are becoming a nuisance over lawn area and these works should reduce this problem.

T2-Sycamore-rear-To balance and contain spread and to improve light into garden suggest: reduce and reshape by approx. 2.5 m, prune back lower growth on garden site.
