The apartment is a single family flat on the second and third floor levels of a late Victorian semi-detached stock brick town house. All the windows to this flat are single-glazed timber framed casement and sash windows. The intention is to replace poor quality 1960s windows with new double-glazed white painted timber casement and sash windows with details, openings, all profiles and frame sizes to match existing, as well as existing timber windows to the lower level, with double-glazed equivalents. The new windows will not change in appearance and will be indistinguishable from the existing windows.
