Please provide a description of existing materials and finishes:	Majority of internal doors within the properties are panelled timber doors with gloss painted finish. Hinges tend to be brass hinges and closers, where present, are polished chrome.
Please provide a description of proposed materials and finishes:	Where panels to doors are 9mm minimum 1nr coat of clear primer will be applied to panels followed by 2nr coats of Envirograf intumescent paint and 1nr coat of topcoat. For doors with panel thickness 6-9mm an intumescent paper faced with a white fire card or a veneer is adhered to the panels with an intumescent adhesive then 1nr coat of clear primer, 2nr coats of Envirograf intumescent paint and 1nr coat of topcoat is applied. Hinges, where required to be upgraded, will be upgraded with Brass hinges to BS EN 1935 and closers will be upgraded with White closes to ensure subtlety to BS EN 1154 and 1634.
