ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at: Wenzel's Bakery, 272 West End Lane, London, NW6 1LJ
as shown outlined in black on the attached plan ("the Property").

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission: Removal of 2 x air handling units to the rear at ground floor level.

4. **REASONS FOR ISSUING THIS NOTICE:**

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years:
- b) There has been a failure to demonstrate that the unauthorised air-handling units would not harm the amenity of any of the surrounding occupiers or neighbours and the air-handling units are currently causing nuisance to adjoining occupiers by way of noise. The unauthorised development is considered to be contrary to policies A1 (Managing the impact of development) and A4 (noise and vibration) of the London Borough of Camden Local Plan 2017.

- C) The unauthorised air-handling units by virtue of its location, design and inappropriate material finish would be harmful to the character and appearance of the property, the wider terrace and West End Green Conservation Area, contrary to policies D1 (Design), D2 (Heritage), A1 (Managing the impact of development and A4 (noise and vibration) of the Camden Local Plan 2017.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. **WHAT YOU ARE REQUIRED TO DO**

Within a period of **three months** of the Notice taking effect:

1. Removal of 2 x air handling units to the rear at ground floor level; and
2. Make good any resulting damage.

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **7th September 2018** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002
