T21 Lawsons Cypress *Chamaecyparis lawsoniana* Rear Garden Very mature tree dominating the small garden, this tree does not lend its self well to the type of pruning required. It is also close to the neighbors retaining wall. Suggested Works: Fell in sections to ground level.  
T31 Ash *Fraxinus excelsior* End of Keats Close, Adjacent Garages This unbalanced self-set tree is growing from a 3m high retaining wall which is showing evidence of cracking and failing. The integral strength of this wall is unknown. Suggested Works: In the interest of public safety - Fell in sections to ground level and poison the stump to prevent regrowth.
