 This application concerns the upgrading and replacement of existing roof top equipment to this listed Grade II building.

The equipment will be installed in an area already occupied by telecommunication equipment. The installations will be set well back from the historic elevations and will not have an adverse impact on the setting or appearance of the host listed building nor from the long views within the Bloomsbury Conservation Area. The scheme is therefore supported.

No comments have been received as a result of the site and press notices.

The site's planning history has been taken into account when making this decision.

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the

Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.
