Species: 1 x Crataegus (Hawthorn)
Position: Rear right boundary
Reason: Overgrown / Shade nuisance
Reduce inward facing side foliage only by approximately 0.5-1m.

Species: 1 x Quercus (Oak)
Position: Near rear right hand side
Reason: Shade nuisance
Lightly cut back lower growth by approximately 95cm, to a height of 4m.
