Rear Garden:

Small Magnolia: The smaller of the two trees is not particularly vigorous but appears in fair condition. Reduce crown by 20% and thin crown density by 20%. Remove dead wood.

Large Magnolia: The larger of the two trees is still vigorous and extremely dense. Raise crown by 1.00m, thin crown density by 20-25% and reduce crown by approximately 20%.

Reasons: To increase light levels and help maintain the trees at reasonable dimensions for their locations whilst maintaining tree health.
