Further to the grant of planning permission by London Borough of Camden (LBC) on 31 August 2017, on behalf of our client, we seek to discharge Condition 11 of the planning permission, which states:

Condition 11

"Full details in respect of the green roof in the area indicated on the approved roof plan shall be submitted to and approved by the local planning authority before the relevant part of the development commences. The buildings shall not be occupied until the approved details have been implemented and these works shall be permanently retained and maintained thereafter."

Please find enclosed a drawing from Orms Architects, Proposed General Arrangement Plant Level Plan Reference RLS-ORM-00-07-DR-A-07007 Revision T06, dated 12 February 2018, which identifies the proposed location and extent of the green roof. The proposed green roof position accords with the layout shown on the approved drawing ref. 2077_X_GA(07)02_XX, rev. P06 from planning permission ref. 2017/3028/P and information approved under Approval of Details of Condition 14, reference 2018/0421/P.
