Fig Tree in rear garden. The tree is causing major damage to my neighbours garage wall that butts up to my property and no 9 Belsize Park. My neighbour is asking we severely cut back the tree as his buildings insurance stipulates that large trees need pruning every two years. The fig is growing rapidly and was pruned back by 1/3 two years ago. It is almost back to the same size and creating large cracks in the garage wall, to the point it is no longer straight and my neighbour is installing a crack measuring device.

I would like to ask for permission to remove on off the offending forks that is causing damage to the roof of the garages and prune the other fork down to a quarter of its current size. I would like to save the tree from being removed completely so suggest this less drastic action.
