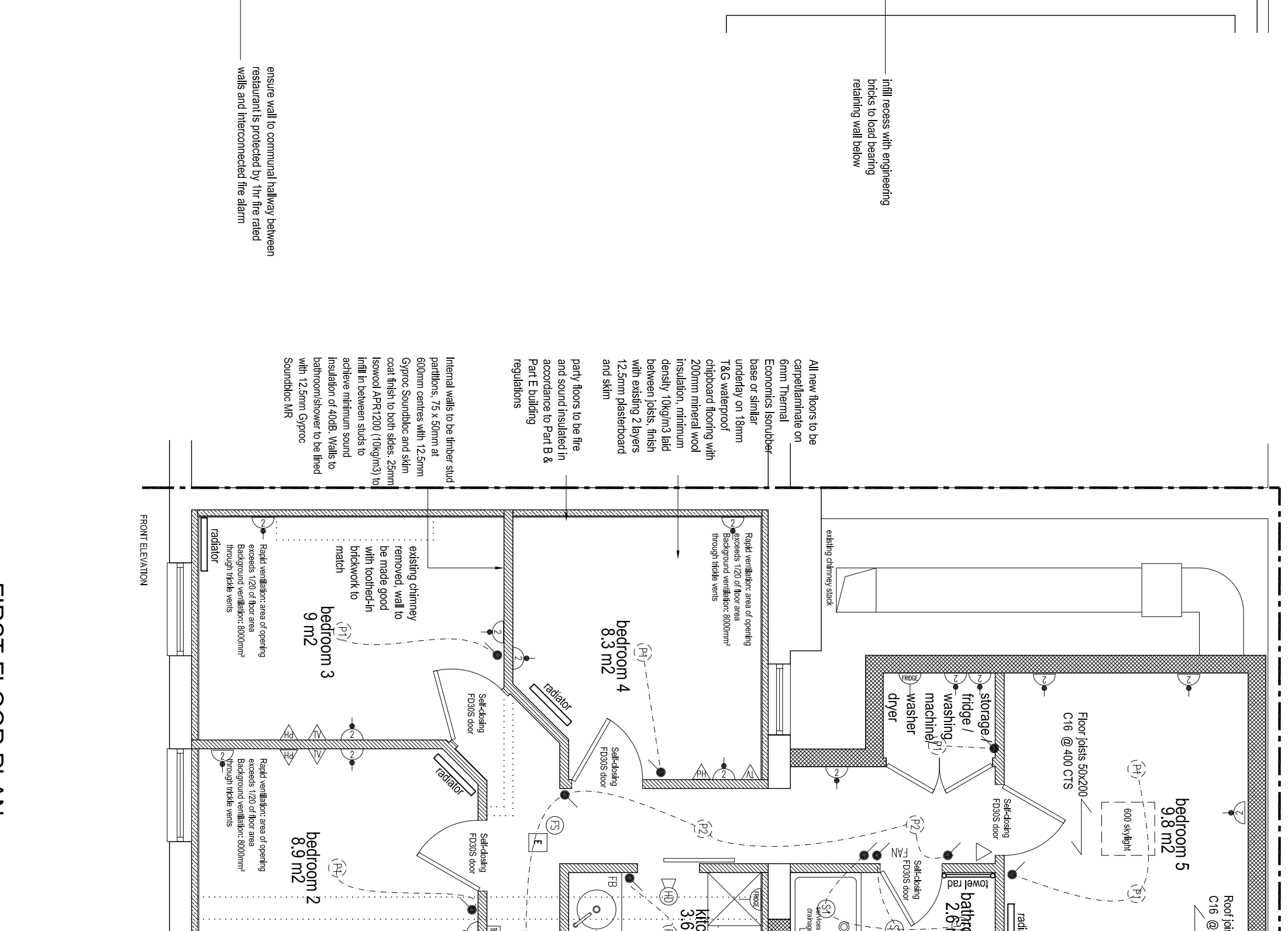

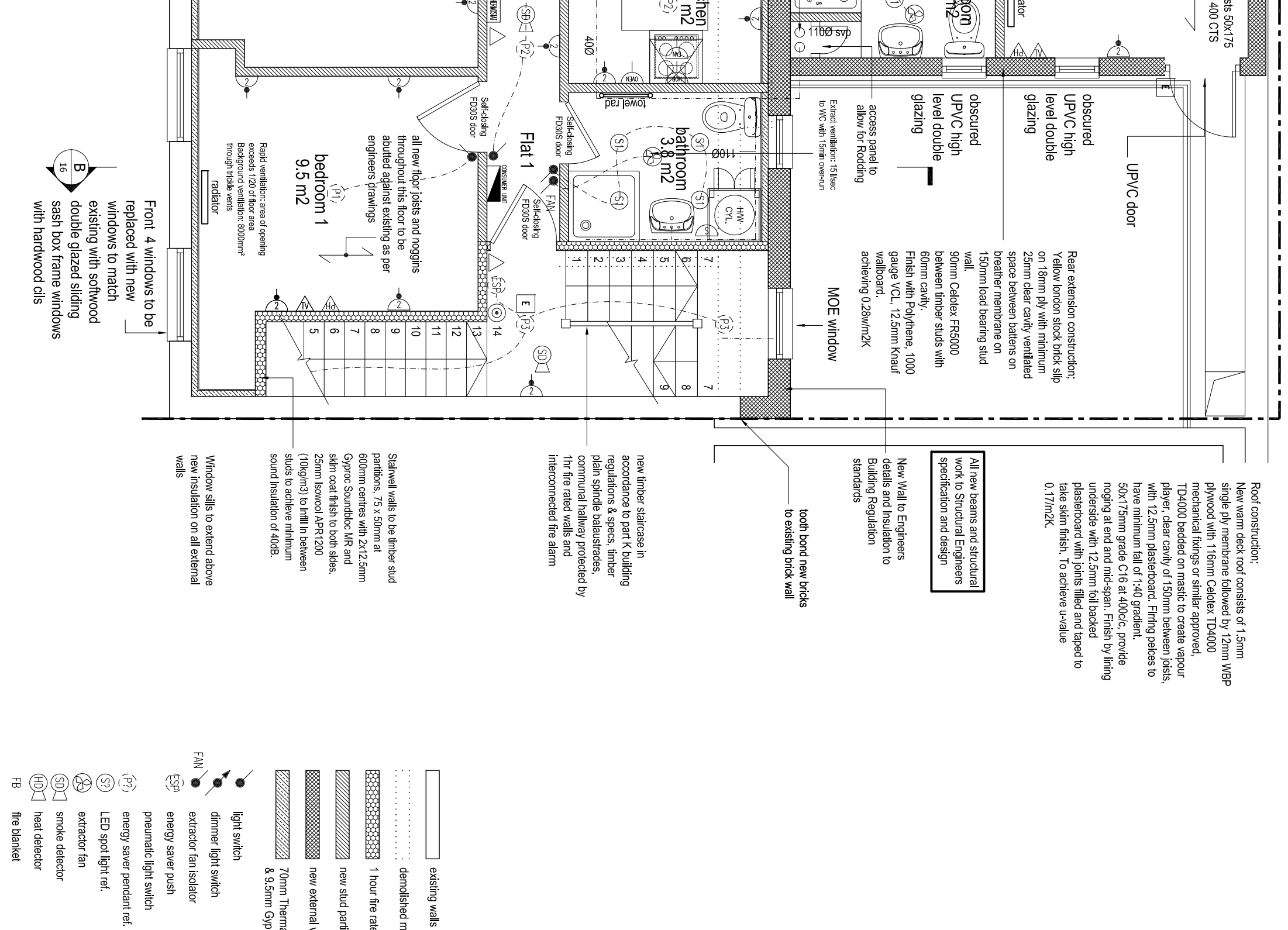

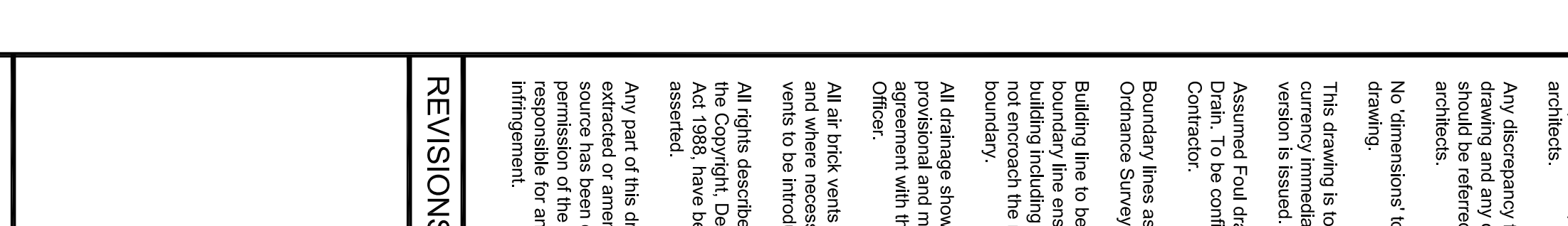
FIRST FLOOR PLAN

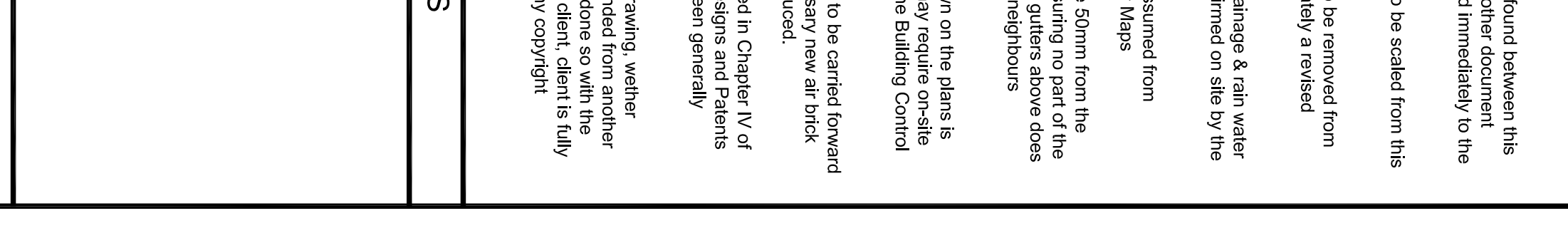
ROOF PLAN

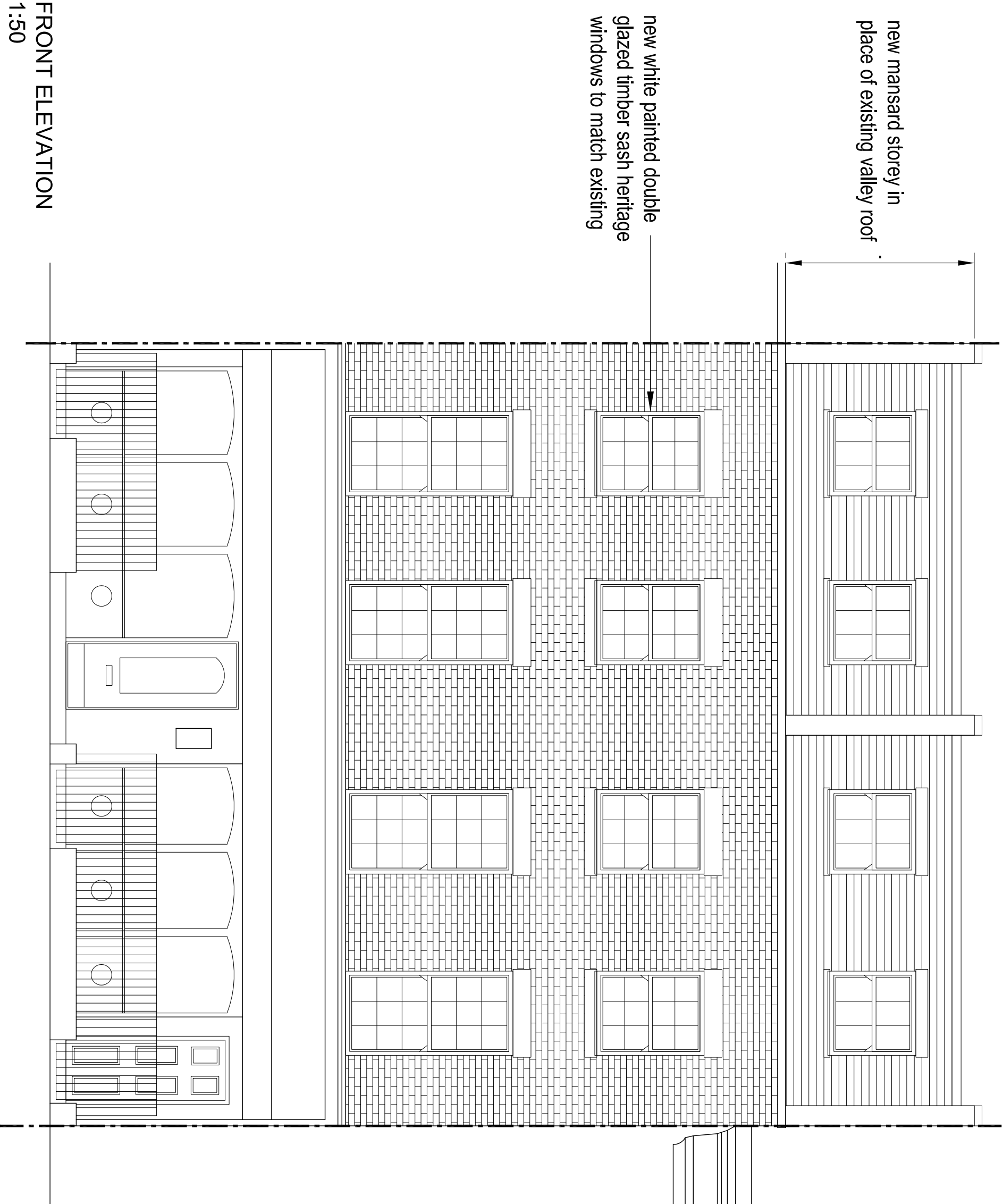

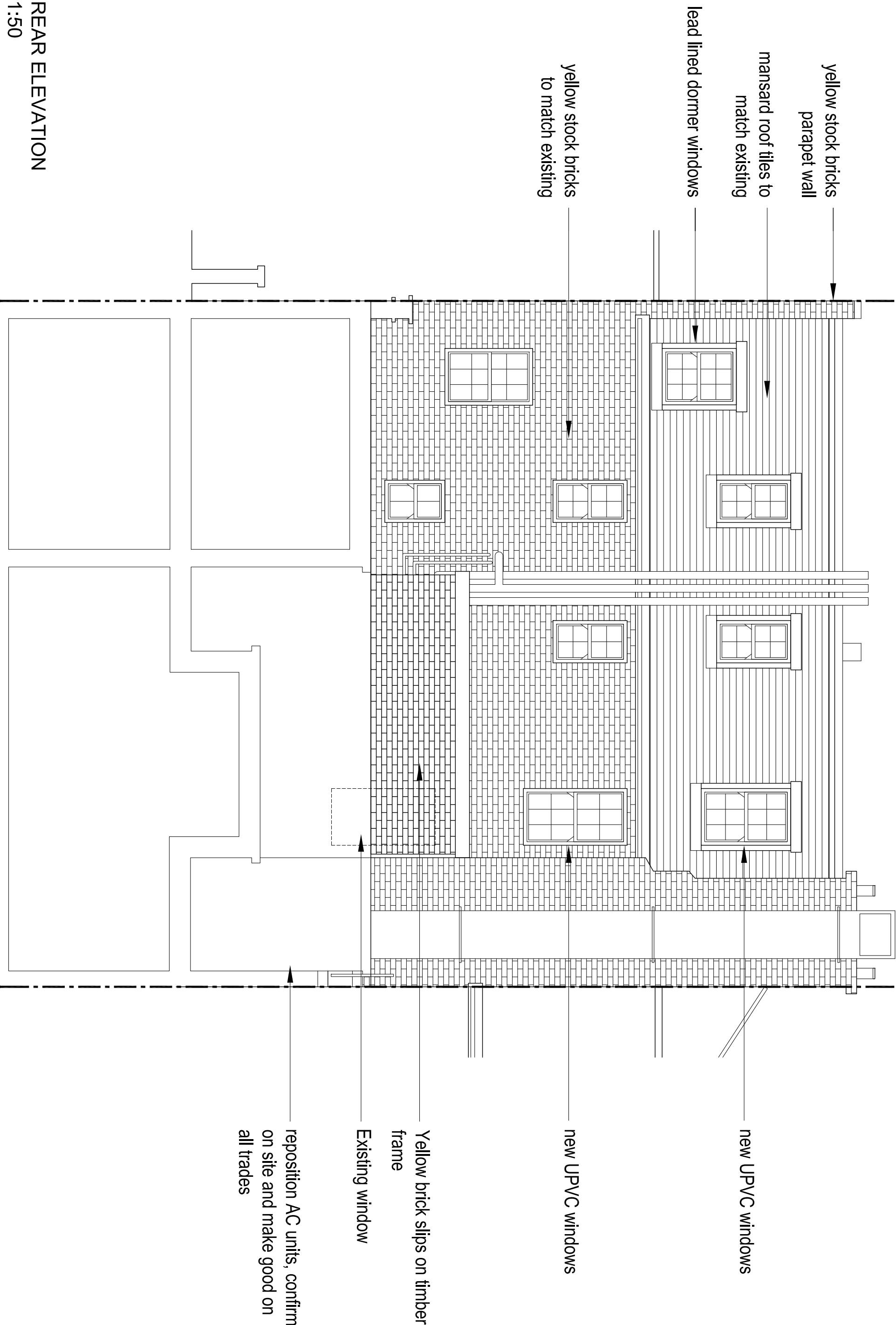
