## Notice of confirmation of pre-registration under article 11(2) of the Feed-in Tariffs ("FIT") Order 2012 of a solar photovoltaic community energy installation with a declared net capacity not exceeding 50 kW, wired at Hampstead Parish Church.

Thank you for your application for pre-registration of the installation.

I am writing to confirm that **Hampstead Parish Church's** application for preregistration as a community energy installation has been approved.

This means that if **Hampstead Parish Church** commissions the installation and applies for FIT accreditation within the validity period stated in the Annex to this letter, it will be entitled to: **receive a relaxation of the minimum energy efficiency requirement to Level G and above with respect to the related building's Energy Performance Certificate** 

The FIT tariff that will be assigned to the installation will be the tariff available on the tariff date. The suite of tariffs available on the tariff date is available from the 'Tariff Tables' section of our website: <u>www.ofgem.gov.uk/fits</u>. The tariff date of the installation will be determined by the deployment cap that your installation falls into, and will be confirmed by your FIT licensee<sup>1</sup>.

## Next steps

When **Hampstead Parish Church** has installed and commissioned the installation and is ready to apply for accreditation, please send a copy of this letter to the FIT licensee together with all other required documentation as requested by the FIT licensee, who will process the application for FIT payments. Any such application must be made within the validity period in order to benefit from the grant of pre-registration.

Please note that the particulars attached to this confirmation of pre-registration are laid out in the Annex to this letter and apply exclusively to this installation.
