Proposal:

Details of disposal of salvaged items required by condition 6 of conservation area consent 2004/2320/C dated 22/12/06 for demolition of various buildings and structures: 1) the Laser Building, located between the Eastern Coal Drops and the Western Transit Shed; 2) the Exel Bridge, over the Regent's Canal, linking Goods Way with Wharf Road; 3) the Bakery Building, fence and gate adjacent to the eastern elevation of the Western Goods Shed and the northern end of the Western Coal Drops; 4) the Filling Station, bounded by the canal to the north, Goods Way to the south and York Way to the east.

Informative(s):

1 Reason for granting permission:

Condition 6 of conservation area consent 2004/2320/C dated 22/12/06 requires any salvaged items not required for re-use on the site to be disposed of to a reputable architectural salvage company, or otherwise as approved in writing by the local planning authority. Many of the salvaged items such as cobbles have been successfully reused on the wider King's Cross site. The applicant has offered the remaining items multiple times to a list of architectural salvage companies. Some items were taken, however many remain and it is now proposed that the remaining items are disposed of. The list of companies offered the salvage items is considered appropriate by the Council's conservation officers and it is considered appropriate measures were taken to reuse all salvaged items on site or elsewhere. It is therefore considered acceptable to dispose of the outstanding items.


The details are in accordance with policy B6 of the London Borough of Camden Replacement Unitary Development Plan 2006.
