e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in the same place.

Rear Garden:

Willow: Reduce hard back to previous reduction points ensuring a suitable amount of furnishing growth is retained.

Fig: Reduce crown by approximately 20-25%.

2 x Sugar Maple: Growing in 65 Frogmal, NW3 6YA to the rear have become very large. At this juncture we seek permission for more extensive pruning work to include the removal of low branch and heavier reduction of the crown and overhang. Reduce crowns by approximately 30-40%, raise crowns over Redington Road property by 2.00-2.50.

Yew: Overhanging from 65 Frogmal, NW3 6YA. Reduce back to as near to the boundary as is practicable whilst preserving tree health. Reduce height by approximately 1.00m.

Reasons: The trees in the rear garden have grown substantially over the past three years and are in need of maintenance works.
