Informative(s):

1 12 Lyndhurst Gardens is a grade II listed building in the Fitzjohns Netherall conservation area. The building is a detached house designed by Harry B Measures and built circa 1886. The building was divided into flats during the 1990s.

The proposals are to replace the windows and two doors at lower ground floor level. The existing windows are single glazed timber sash windows, they are not historic but are in poor condition. The proposed windows will match the existing. The existing doors are modern replacements, the new doors will match the existing.

The proposed works will not harm the special interest of the grade-II-listed building.

The application has been advertised in the press and by means of a site notice, whereby there were no consultation responses. The site's planning history has been taken into account in making this decision.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in general accordance with policy D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the NPPF.
