Pruning back all branches growing north over neighbouring property (13 Eaton Avenue) back to boundary to maintain crown spread, leaving a balanced crown throughout.
Walnut (T2) - 30% crown reduction, reducing the height of the tree to approximately 6M and reducing lateral branches by 1.5 metres to balance crown. Pruning back all branches growing north over neighbouring property (13 Eaton Avenue) back to boundary to maintain crown spread, leaving a balanced crown throughout.
