Dear Labeed,

Re: 22 Frognal Way Pile wall change

I write following my meeting with London Borough of Camden Tree Officer Tom Little on 20th August 2018 at 22 Frognal Way to discuss alteration of the position of the piling wall adjacent to the lime and beech trees to the north of the consented development.

He examined both the current extent of piling mat / bomb risk assessment excavation and latest 3 trial pits from Arboraeration (enclosed herein) and confirmed to me that he thought the extent of the current dig fine and that trial pits warranted a further 500mm engineering space dig into the lime RPA but not of the beech.

Following this, the final excavation line was set out accordingly. This is some 3m inbound (to RPA / CEZ) of the consent line but will be of no harm to trees as few if any significant roots will be affected. The works will though require pruning of the second primary limb of the TPOd lime back to the 30cm diameter scaffold branch located just inbound of thepiling line.

A separate TPO app will be required for this pruning, but the Officer accepts it is a lime tree and relatively robust with again no harm envisioned.

I trust the above provides sufficient confirmation of the position of the London Borough of Camden...
