Suggested works : Fell to ground level and treat stump to prevent any further growth.

T2 Silver Birch x 1 (Betula pendula/ alba) Reduce height by approximately 2m. Reduce lateral growth by approximately 1.5m. Raise crown over the road to approximately 4m - Clean out crown and remove dead wood.

Front
T3 Holly x 1 (Ilex aquifolium) Remove the stem on the left hand side. Trim remaining stem to achieve a neat rounded outline.

Rear
T5 Ginkgo/Maidenhair (Ginkgo biloba) Reduce height to approximately down to half Tree x 1 way of the bedroom window. Reduce lateral growth by approximately 0.75m to try to achieve a column shape.
