e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in the same place.

Rear Garden:

T1: Hornbeam: Reduce crown by approximately 30%, thin crown density by 25% and remove dead wood.

T2: Laurel: Fell to ground level and grind stump to approximately 300mm below current ground level - Reason - due to overcrowding.

T3: Laurel: Remove low branch protruding over the lawn, reduce remaining overhang by 20% and remove dead wood.

G1: Group: Consisting of holly, lilac, hawthorn and yew, forming hedge line to the rear boundary. Reduce overhang by 30%.

T4: Yew: Pruned into hedge form. Reduce height by 20-25% and reduce overhang by 20%.

T5: Yew: Large and rose covered. Reduce extraneous rose throngs back into main crown structure. Reduce/trim the lower, currently exposed, section of the crown by 20%.

Forsythia: Reduce overhang hard back, reduce remaining crown by 25% to tidy whilst retaining some screening
