Oak (T1) - Reduce vertical and lateral branches by up to 3m, leaving furnishing growth. The tree has significant basal decay and requires heavy pruning to minimise likelihood of failure. Large fruting bodies of Meripilus giganteus has been observed at the base of the tree over a number of years. Horse chestnut (T2) - Reduce crown back to previous most recent cuts.

Sycamore (T3) - Reduce crown back to previous most recent cuts.

Horse chestnut (T4) - Reduce crown back to previous most recent cuts.
