## **ENFORCEMENT NOTICE**

# ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

## 2. THE LAND TO WHICH THE NOTICE RELATES

Land at: 72-74 Parkway, London, NW1 7AH shown outlined in black on the attached plan ("the Property").

# 3. THE BREACH OF PLANNING CONTROL ALLEGED

Without planning permission: New windows installed at first and second level, front elevation, following removal of previous windows.

## 4. REASONS FOR ISSUING THIS NOTICE:

- a) It appears to the Council that the above breach of planning control has occurred within the last 4 years.
- b) The windows that have been installed, by reason of their design, materials and appearance form a discordant and incongruous alteration which fails to relate to the visual appearance and character of the building, the streetscape and the Camden Town Common tion Area. As such, the works are contrary to policy CS14 (Promon the Quality Places and Conserving Our Heritage) of the London Camden Local Development Framework Core Strategy (Securing High Quality Design) and DP25 (Conserving)



Heritage) of the London Borough of Camden Local Development Framework Development Policies.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

### 5. WHAT YOU ARE REQUIRED TO DO

Within a period of *three months* of the Notice taking effect:

Within three months, the windows to the front first and second floor elevations shall be completely removed and replaced with windows to match the originals.

### 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 28th June 2018 unless an appeal is made against it beforehand.

# Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.

The fee is payable twice to the "London Borough of Camden", as the Local Planning Authority.


#### YOUR RIGHT OF APPEAL

#### WHAT HAPPENS IF YOU DO NOT APPEAL

Failure to comply with an enforcement notice, which has taken effect, can result in prosecution and/or remedial action by the Council.
