New show related signage for the Come From Away show at The Phoenix Theatre. The main sign on the rotunda elevation is fixed to the columns. The lettering is yellow with a neon tube running around the perimeter of each letter. The signs either side of the main rotunda sign are digitally printed vinyl signs inserted into the existing venue sign boxes. The existing "Phoenix" lettering on the sign is to be removed and replaced with the "Come From Away" sign made from aluminium letters fixed to the existing signage structure. The sign on the corner of the building at the junction of Phoenix Street and Charing Cross Road is to be removed and replaced with aluminium backed panels fixed to the existing sign structure. The existing street level poster boxes are to have digitally printed vinyl inserts for the related show.
