ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at: The Old Oak Public House, 1 Mansfield Road, Hampstead, London NW3 2JD shown outlined in black on the attached plan ("the Property").

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission: the installation of a roof enclosure at first floor level

4. **REASONS FOR ISSUING THIS NOTICE:**
 - a) It appears to the Council that the above breach of planning control has occurred within the last 4 years

 - b) The unauthorised timber enclosure by reason of its siting, height and size dominates the host property detracting from its character and appearance and is an incongruous addition to the streetscene. It also obscures architectural features at first floor level to the detriment of this Locally Listed building. The development is therefore contrary to policies A1 (Managing the

Impact of Development), D1 (Design) and D2 (Heritage) of the Camden Local Plan 2017.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. **WHAT YOU ARE REQUIRED TO DO**


Within a period of **one month** of the Notice taking effect:

- 1) Remove the timber enclosure at first floor level in its entirety.
- 2) Remove all debris relating to the enclosure from site.
- 3) Make good any damage to the building as a result of the works.

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **16th October 2018** unless an appeal is made against it beforehand.

Note Pursuant to Regulation 5 of the Town and Country (Enforcement Notices and Appeals) (England) Regulations 2002

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
