- Lime (T3) Reduce crown by up to 2m. Remove epicormic growth to thin the crown, leaving some lower growth for privacy
- Lime (T4) Reduce all growth growing towards the building, back to previous cuts. This tree is in the rear garden of No 1 Buckland Crescent NW3
