Rear garden of 73 Redington Road overhanging gardens

Very large mature tree with a tree preservation order. To improve light and clearance into rear gardens of 31 and 33 Hollycroft av and improve form of tree: Reduce canopy height by approximately 2-3m, reduce south, west and east lateral spread by 2m, and overlong branches back into main canopy line. Retain inner branch structure for crown continuity. Crown lift over rear garden of 33 by 2-3m. Remove deadwood, weak or suppressed branches. Clean out crown from sucker growth.
