Selectively reduce crown height and lateral branches by 1-2m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy. Crew to speak to client prior to start.

REAR garden with side access

T2 = Medium WILLOW - Crown reduce height by 8-10m, (0.5m above fence height).

T3 = Large SUGAR MAPLE –

Reduce crown height by 8-10m, reduce lateral branches by 13-4m, pruning back to suitable growth points as per previous practice, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.

T4 = Large LAUREL –

Reduce crown height by 3m, reduce lateral branches by 2-3m, pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.

T5 = Large MAGNOLIA –

Thin lateral branches to ease weight towards building, selectively reduce laterals to shape.
