## 5. Identification of Tree(s) and Description of Works

Front Garden:

T1: Large Fig: Re-pollard/prune back to previous reduction points whilst preserving as much secondary furnishing growth as possible.

G1: Fig Group: Located along boundary wall. Reduce by approximately 20%.

Front Garden:

T3: Acer: Snake Bark. This specimen tree is becoming too large for its location. We recommend; reduce crown by 20-25% and thin crown density by 20%.

T4: Sambucus: Located near to house. Reduce crown by 25-30%.

T5: Holly: Located on rear boundary. This tree forms part of the important screen from the property to the rear. However, it would be prudent not to allow this

(or the adjacent lime trees) to exceed its current dimensions. Reduce back to previous reduction points, approximately 1.00-1.50m

T6 & T7: Pollarded Limes: These trees are also valuable for the screening they provide. Reduce height/vertical growth only back to previous pollard points. The lateral and sub lateral growth is to be retained for screen.

T8: Small Pear: Reduce crown height by 20%.

T9: Paulownia: This tree grows extremely quickly. Reduce back to previous reduction points.

T10: Magnolia Grandiflora: Reduce height by 15% to help induce lower growth habit.

T11: Hoheria Stardust: Reduce crown by approximately 25%.

Reasons - General maintenance and management.
