Front Garden:

Birch: Continuation of the previous management plan. Thin crown density throughout by 20%, reduce overlong extraneous branches back into main crown structure, approximately a 20% crown reduction and remove dead wood.

Malus: Remove dead wood. Reduce crown by 20% and thin crown density by 20%.

These actions will help manage the trees at reasonable dimensions for their locations whilst preserving health, natural characteristics and aesthetic value.
