Centre Point (includes Centre Point Tower, Centre Point Link and Centre Point House), 101 and 103 New Oxford Street and 5-24 St Giles High Street, London, W1 Condition 6 parts d and g of listed building consent ref. 2015/5069/L

On behalf of our client, Streatmarkets Ltd, we enclose for your attention and consideration an application to formally discharge condition 6 parts d and partially discharge condition 6 part g, attached to the listed building consent in respect of the proposed RO1 unit at Centre Point (2015/5069/L).

## Background

On 5 April 2016 listed building consent (ref: 2015/5069/L) was approved for:

"Internal and external alterations associated with the erection of a ground floor extension partially infilling beneath Centre Point Link affecting a Grade II Listed Building."

The tenant, Streatmarkets Ltd., have submitted an application for listed building consent (ref: 2018/4514/L) for the internal fit out of the unit.

A partial approval of details pursuant to condition 6g was approved on 11 December 2017 (ref: 2017/2854/L). This original approval of details related solely to the lighting that the landlord was responsible for delivering at the site and did not relate to tenant fit-out lighting.

Accordingly, this application to partially discharge the remaining details pursuant to condition 6g relates to the tenant fit-out lighting and does not seek to supersede any previously discharged details under application ref: 2017/2854/L.

## **Condition 6d**

Condition 6d states:

"Detailed drawings, samples of materials and method statements as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council before the relevant part of the work is begun:

d) Samples and manufacturer's details for all internal floor surfaces."

Gerald Eve LLP is a limited liability partnership registered in England and Wales (registered number OC339470) and is regulated by RICS. The term partner is used to refer to a member of Gerald Eve LLP or an employee or consultant with equivalent standing and qualifications. A list of members and non-members who are designated as partners is open to inspection at our registered office; 72 Welbeck Street, London W1G 0AY and on our website.



In accordance with the requirements of Condition 6d we enclose proposed plan drawings demonstrating the proposed internal floor surface materials at all levels of the unit.

The design commentary document, dated 24 October 2018, presents the design rationale for the chosen materials which is founded in celebrating the character and appearance of the listed building.

## **Condition 6g**

Condition 6g states:

"Detailed drawings, samples of materials and method statements as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council before the relevant part of the work is begun:

g) Details of all lighting fixtures, fittings, cabling and fixing methods."

In accordance with the requirements of Condition 6g we enclose proposed lighting layout, prepared by into, and installation plans, prepared by Lehding Services Design Ltd., demonstrating the proposed locations and methods of fixing to the fabric. Also submitted are lighting specification and concept documents, prepared by 'into' which explain the design rationale behind the internal lighting proposals at the site.

The information submitted correlates with that submitted under the currently pending tenant listed building consent fit-out application (ref: 2018/4514/L), which was discussed during a number of preapplication meetings.
