Erection of single storey rear extension to dwelling house following demolition of existing rear structure [subsequent to prior approval granted on 07/08/2018 under ref: 2018/3652/P]

The application building is a three-storey mid-terrace dwelling house located on the northern side of Belsize Road. It is not situated within a conservation area.

The proposed measurements of the rear extension are 4.5m in depth, 3.2m in its maximum height and 3m eaves height along the boundary with No. 12 and No. 16 Belsize Road.
