ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. **THIS IS A FORMAL NOTICE** which is issued by the Council because it appears to them that there has been a breach of planning control, under Section 171 A (1) (a) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations. The Explanatory Note at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at: 17A Nassington Road, London, NW3 2TX as shown outlined in black on the attached plan (“the Property”).

3. **THE BREACH OF PLANNING CONTROL ALLEGED**

Without planning permission: Installation of razor wire on the flat roof of the rear extension.

4. **REASONS FOR ISSUING THIS NOTICE:**
 - a) The unauthorised development has occurred within the last 4 years.
 - b) The works that have been carried out fail to respect the residential nature of the property and, by their obtrusive and incongruous design, fail to relate to the character and appearance of the property and the South Hill Park Conservation Area. As such, the works are contrary to Policy D1 Design and Policy D2 Heritage of the Camden Local Plan 2017.
 - c) The works that have been carried out give the impression of an embattled neighbourhood where properties require heavy

fortification to ensure safety; as a result they do not make Camden a safer place and fail to comply with policy CS5 Safety and Security of the Camden Local Plan 2017.

The Council do not consider that planning permission should be given because planning conditions could not overcome these problems.

5. **WHAT YOU ARE REQUIRED TO DO**

Within a period of **one month** of the Notice taking effect:

1. Completely remove all razor wire from the flat roof of the rear extension;
2. Make good any resulting damage following the completion of the above works.

6. **WHEN THIS NOTICE TAKES EFFECT**

This notice takes effect on **14 December 2018** unless an appeal is made against it beforehand.

If you appeal against the notice on Ground (a) "That planning permission should be granted for what is alleged in the enforcement notice, or that the condition which is alleged not to have been complied with should be discharged" there is a fee payable under Regulation 10 of the Town and Country Planning (Fees for Applications, Deemed Applications, Requests and Site Visits) (England) Regulations 2012/No.2920 for the deemed application for the planning permission for the development alleged to be in breach of planning control in the enforcement notice.
