I have heard that Breast Cancer Haven is having to move out of its Fulham home of 20 years because of the lease expiring in September 2019. In January of this year I was diagnosed with breast cancer. Fortunately I had surgery and follow up treatment very quickly and am now free of cancer, but I am still accessing the services provided by Breast Cancer Haven. The support they offer to all women who are struggling with diagnoses and the implications that has for the future is essential for recovery and well-being, at the time of diagnoses and long after. The Haven provides a safe, comfortable space to meet other people, share feelings and experiences, have one to one support, get advice on healthy eating, find information on life adjustments during and after treatment, attend workshops and events and generally supports women at a very dark point in life.

A friend recommended the Haven to me when I received my diagnosis and I have found them to be a valuable resource and place of support. The staff are extremely helpful, understanding and supportive. The sessions are personalised and tailored for each individual with bookings made at a pace determined by that individual. Recovering from, or living with, breast cancer is not about treatment alone. The Haven provides a vital service by offering other forms of support for women, form counselling to beauty treatments to advice on diet and nutrition to classes, workshops, courses and support days. This is a unique and essential service. And all this is free and accessible without the need to be referred by a GP. I cannot overemphasise how important it is for Breast Cancer Haven to be in the most accessible location possible in London to enable more people affected by the disease to get the help they so desperately need, and this is why I am writing to you today to ask you to grant the application for a change of use for the property Breast Care Haven hope will become Future Dreams House, Birkenhead Street, Kings Cross.
