Following our visit to the site on 17th July, our technician found evidence of a large number of rat burrows around the property suggesting high levels of activity.

Proposal-

In order to begin the eradication of the Rat activity, it is recommended that our technician attends site on the 9th October to in the region of 10 external bait stations containing specialist wheat based rodenticide targeting the specific runs of the rodents.

We recommend revisiting site 14 days later to assess the level of consumption of the bait and to restock the boxes and remove any deceased rodents which may be present.
