(TPO REF. C265) CORAM CAMPUS GROUNDS: 1 x Large Plane (T7) - Crown lift to 6 - 7 metres, cut back from property to give a 1.5 - 2 metres clearance.

1 x Large Plane (T22) - Cut back from flood lights to give a 1.5 - 2 metres clearance only

1 x Large Plane (T23) - Crown lift to 6m removing trunk growth

1 x Large Plane (T35) - Cut back from flood lights to give 2 metres clearance

The Council has considered your application dated 26 September 2018 and decided to grant consent subject to the following condition(s):
