All responding recipients of letters (appended) have been very pleased and have voiced their positivity for the way that the deliveries, noise and site cleanliness have been approached, they have been pleased to hear that the works at 10 & 11 Kings Mews are going to be started and controlled by Dropbox Basements in order the works to the mews will be constructed concurrently which will draw the conclusion of the works to a close sooner than if the projects were back to back.

Dropbox have been working in collaboration with the contractors at no's 26 and 29 Kings Mews with whom they have meet daily/weekly in order to discuss and agree deliveries, collections and the like and have now been appointed to carry out the superstructure works at 28 Kings Mews in order the volume of contractors working within the mews is minimalized. This is in an attempt to maximise the delivery volumes to minimise the construction traffic journeys to the mews.

The commencement date for the project will be posted along with all contact numbers on the site hoarding as soon as the date is known, asking people to make contact with Dropbox Basements directly should they have any questions, queries or concerns.
