1 Reasons for granting approval.

Condition 3 of permission 2015/1925/P requires sample panel in respect of the new brickwork, demonstrating the proposed colour, texture, face bond have been provided. A brick sample panel was inspected and judged to be of high

quality. The submitted Black smooth brick and Reglit (Channel Glass) and Insulation confirm the specification of the materials. Overall the details are considered appropriate and provides a satisfactory contextual response to the building, street scene and surrounding conservation area.
