## 5. Identification of Tree(s) and Description of Works

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in the same place.

#### Front Garden:

T1 = Large Lime - This tree has a pronounced lean over the street and is completely obstructing the adjacent street lamp. The root bulb of this tree is also exposed, showing loss of stability due to an imbalance of the root structure between the building and street side.

As a minimum; we recommend that this tree be reduced by approximately 50%, back past all previous points of reduction to leave nothing but a bare framework.
