T1Tree of Heaven x 1 (Ailanthus altissima) Large mature Tree of Heaven in the front garden of No. 2 South Villas that overhangs the neighbouring property and public footpath. This tree has been previously reduced in order to contain its size within the given location. Suggested works: Re-reduce all aspects of the crown to contain the size of this tree and allow more light to reach the neighbouring property. Reduce from street lamp to give a clearance of 2 meters. Remove dead wood.
