1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the

London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans Site loction plan 18/017/001A, 18/017/003, 18/017/002, 18/017/004, 18/017/002A, 18/017/003A.

Reason: For the avoidance of doubt and in the interest of proper planning.

- 1 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - 3 Reasons for granting permission.

The proposal to replace timber framed sash windows is considered acceptable as the new windows will match the existing style, material and colour. The only discernable difference will be the addition of double glazed windows, and this will be hardly noticable from the public realm.

The proposal is considered to preserve the character and appearance of the host building, the street scene and of the wider conservation area.

The alterations are not considered to harm the amenity of any neighbouring properties.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

No objections have been received. The sites planning history was taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies D1, D2 and A1 of the Camden Local Plan 2017 and policies DH1 and DH2 on the

Hampstead Neighbourhood plan (2018). The proposed development also accords with the London Plan 2016 and the NPPF 2018.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2018.
