Proposal:

(TPO REF. C5-1967) IN GARDENS: 1 x Plane (T76) - Fell to ground level. (TPO REF. C5-1967) 2 x Planes (T85 & T86) - Reduce branches in line with tree report

The Council has considered your application dated 02 October 2018 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- This decision is valid for 2 years from the date of this decision or until the work is completed, which ever is the sooner.
 - Reason: To allow the Local planning authority to monitor the completion and standards of the work.
- All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)



Reason: To ensure the preservation of the amenity value and health of the tree(s).

Prior to the end of March following the completion of works, a Pinus nigra (black pine) shall be planted as a extra heavy standard with a girth size of 16-18 cms. The ground should be prepared to the standards set out in BS5236:1975. The tree should be suitably staked and tied.

Reason: In order to comply with the provisions of Section 206 of the Town and Country Planning Act 1990 (as amended).

Informative(s):

Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
