2018/4742P	Mr chris christodoulou	15/11/2018 11:27:30	OBJECTION	<p>I strongly object to this proposed planning permission, on the grounds of blocking out natural light, overlooking my garden, noise and construction disruption to our daily lives</p> <p>my mother shelagh christodoulou [REDACTED] is 81 years old suffers from onset senile dementia a bad hip/knee that had to be replaced and in general not great health, the noise and stress these works would cause to my mother is not acceptable in any way shape or form</p> <p>I myself am awaiting surgery in february 2019 and currently stuck indoors due to ill health so this would also impact me while i'm recovering and i feel would effect my recovery and health having major building works going on!</p> <p>also my so called neighbour only told me it was a one story extension now i find out it is a 3 story one?</p> <p>my neighbour has been renting out his property for years this proposed extension i feel is just another excuse to get more tenants in and maximise his profits!</p> <p>I have a on going dispute with my neighbour over damage he caused [REDACTED] when a diseased tree on his property that he had ignored came down over my garden destroying my greenhouse flattening mature plants and garden 6yrs ago!</p> <p>at the time he said he would pay for any damage caused he did get a clean up crew in to remove the tree (after i spent 8hrs cutting it apart with a electric saw myself) and cleared it. 2days later but this could have easily killed someone if they were in my garden when it came down</p> <p>again despite claiming he would pay for all damage this caused he never did! soon after he moved out and rented the property until a couple of months ago when he moved back in last month i was informed of a party wall application for under pinning work</p> <p>I forward this as to try and show the character of this applicant he is not in this to the betterment of his family his motive is profit pure and simple!</p> <p>myself and my family will fight this application on every legal level we can and hope Camden council will help us in not granting permission for these works to be carried out</p> <p>thank you very much for your time</p> <p>chris christodoulou</p>
