The new basement window is entirely out of keeping with the otherwise remarkably well-preserved basement windows along this terrace. It is metal-framed – it looks like a crittall window. All the other basement windows along this terrace are wood-framed sashes. The window is much taller than all the other windows, reaching almost to ground level. Also, the installation of an entire glass wall in place of the masonry-rendered wall that makes up the entrance wall of the basement is entirely out of keeping with the rest of the terrace. The glazed bricks are not in style with any other property anywhere in the neighbourhood. I cannot see any drawings in any of the earlier applications either for the front window or the masonry side wall. This work was carried out entirely without permission. This terrace is particularly well-preserved. These new elements are absolutely an infraction of planning rules in this conservation area and should not be allowed to get through. Please note, there is precedent in Princess Road for windows to be put back as were previously. See paperwork for 35 Princess Road (circa 1996). The owners ripped out the original Victorian window and replaced it with a large single plate glass window. They were obliged to remove the plate-glass window and replace it with an identical sash window like the one they ripped out.
