Thank you for providing comments on the above applications. I am looking to recommend approval of the applications, for a temporary period of up to 5 years.

The agent is keen to avoid any pre-commencement conditions and has sent through information on the foundations/loading of the proposed kitchen pod (see attached). The agent notes: Essentially this will sit on a new c300mm concrete raft adjacent to the existing 400mm slab that was constructed for the marketing suite. The pod would then be craned into position. Chapel Down's structural engineers have done some assessment of loading applied at underside of raft and, given the average distance between the edge of the raft and the canal wall (approx. 2.5m) it was concluded that there would be negligible load effect on the canal wall from the pod. I have attached their raft calculations.

Could you please let me know whether the above information and attached plans are sufficient to avoid attaching the pre-commencement condition that you had suggested?
