# Certificate of Lawfulness (Proposed) Granted

## Reason for the Decision:

The rooflight in the side and rear roof slope is permitted under Class C of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015.

# Informative(s):

1 The development subject to the grant of this certificate would only constitute permitted development if the upper floor window on the side elevation of the dwelling house is obscure-glazed and non-opening, unless the openable parts of the window are more than 1.7m above the floor of the room in which the

window is installed, in accordance with Condition C.2 of the Town & Country Planning (General Permitted Development) Order 2015.

- The development subject to the grant of this certificate, would only constitute permitted development where the roof lights would not project more than 150 mm beyond the plane of the roof slope in accordance with Condition C.1(b) of the Town & Country Planning (General Permitted Development) Order 2015.
- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings.
