I write with respect for the planning application at the above site 61 Birkenhead street Kings Cross. We met over a month ago to discuss this proposal. The transfer of a premises designation from B1 to D1 is rarely done. However the case in this instance is **exceptional**.

Having Cancer is one of the worst things that can happen to a person, so to have a place where you can go and be surrounded by caring individuals in a venue where you can escape everyday life and "feel safe and loved" is something we want to nurture here in Camden. The facts are stark, 1 woman in 8 in the U K run the risk of developing the disease at some point in their lifetime, a huge cohort of people who deserve 'hands on support' from a holistic service which is held in revered esteem by its users.

“The aim of Future dreams house, home to Breast Cancer Haven is to provide a safe, caring accessible, kind and person centred base for people with breast cancer. This will have a hugely positive impact on the women’s ability to complete their treatment (side effect management) adjust to their diagnosis (be that into survivorship or if diagnosed as having a terminal disease) and re-establish their role in society.”

As you know, time is tight, the Haven needs new premises early next year and we would welcome such a resource in Camden. The transport system in Kings Cross has excellent links across the Capital, and indeed is accessible to outer London.
