e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in the same place.

Front Garden:

T1: Ash: Approximately 11.00m. This tree is carrying a significant amount of dead wood. Several branches are touching the rear of the building. Remove dead wood. Reduce crown by approximately 20-25% to previous reduction points whilst preserving a suitable amount of furnishing growth to ensure crown continuity. Reason: abate nuisance and reduce potential hazards.

Rear Garden:

T3: Lime: Approximately 18.00m. Reduce crown back to previous reduction points whilst preserving a suitable amount of furnishing growth. Reduce crown density by 20%. Remove dead wood. Raise crown over pavement by 1.00m. Reason: Some cracking to the boundary wall is evident and can be attributed to the tree.

T4: Lime: Approximately 15.00m. Reduce back to previous reduction points whilst preserving a suitable amount of furnishing growth to ensure crown continuity. Remove epicormic growth from the fence. Raise crown by 1.00m. Remove dead wood.

T5: Beech: Approximately 17.00m. A longitudinal column of decay was noted to the rear of the tree. Thin crown density by 20%. Remove major dead wood throughout. Reduce extraneous branches back into main crown structure (not more than 15-20%) in order to maintain the tree at reasonable dimensions for its location.

Reason: General maintenance unless otherwise specified.
