The previous application (2018/3363/P) was refused (and is now the subject of an appeal). When I met the case officer, Ms Constantinescu, on site, she advised me that if the extension were not full width, if it were reduced in width on the downhill side, to be in line with the rear outrigger, it would be likely to be acceptable. That is what is proposed in this application.
