We inspected this site and noted 2 x XLarge London Plane trees blocking out light/air to the buildings/gardens. We advise:

FRONT garden with side access on Colonnade

T1, T2 = 2 x XLarge LONDON PLANES –

Reduce crown height by 3-4m, reduce lateral branches by 3m (regrowth), pruning back to suitable growth points, leaving shortened selected secondary growth to form a smaller neater symmetrical shaped canopy.
