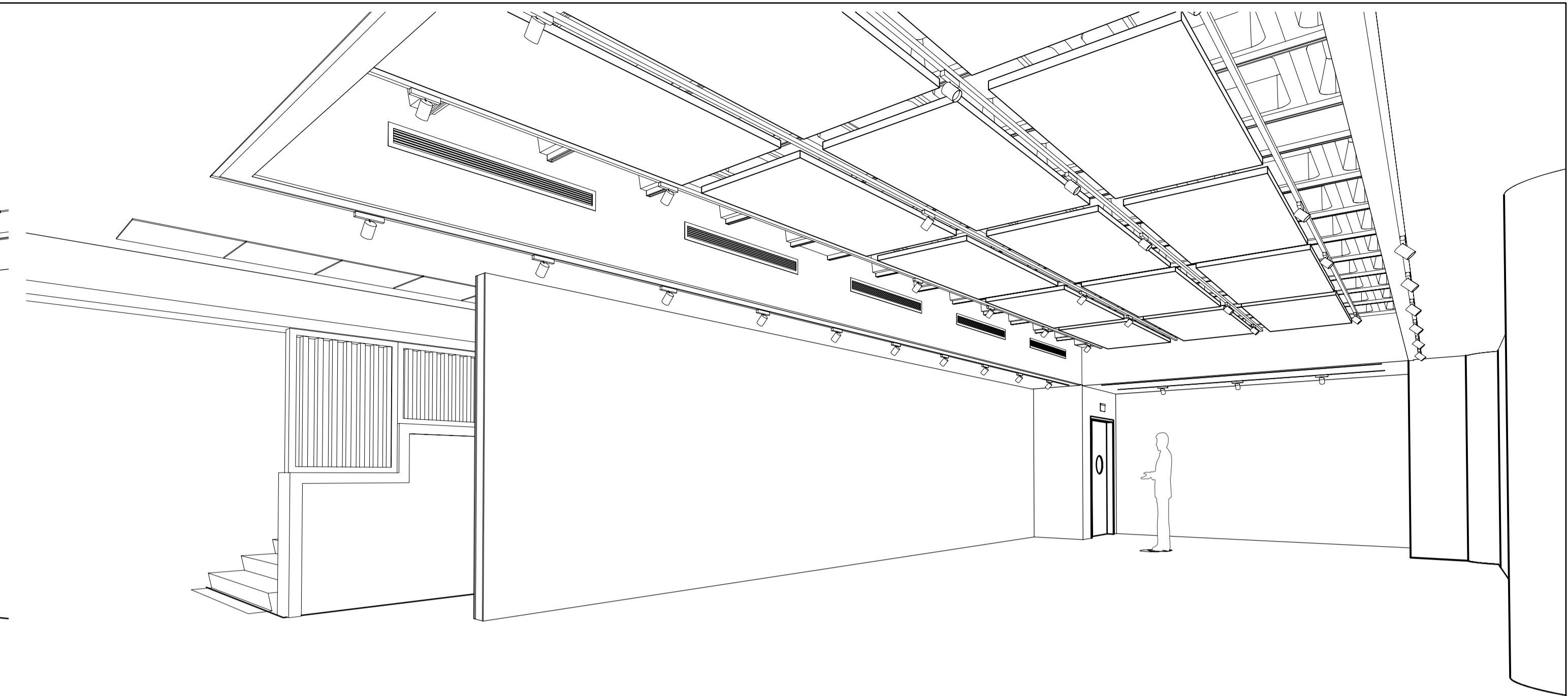
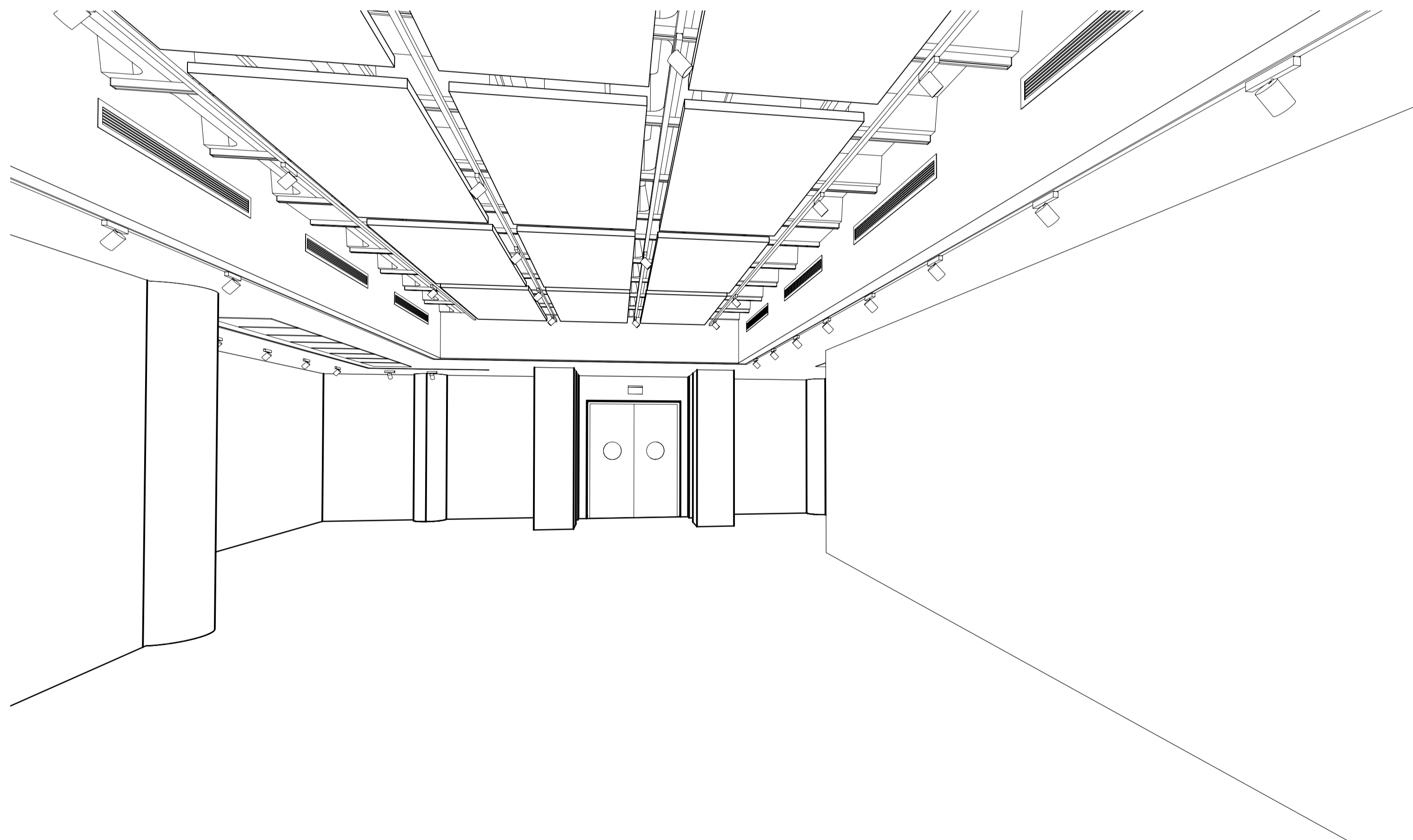


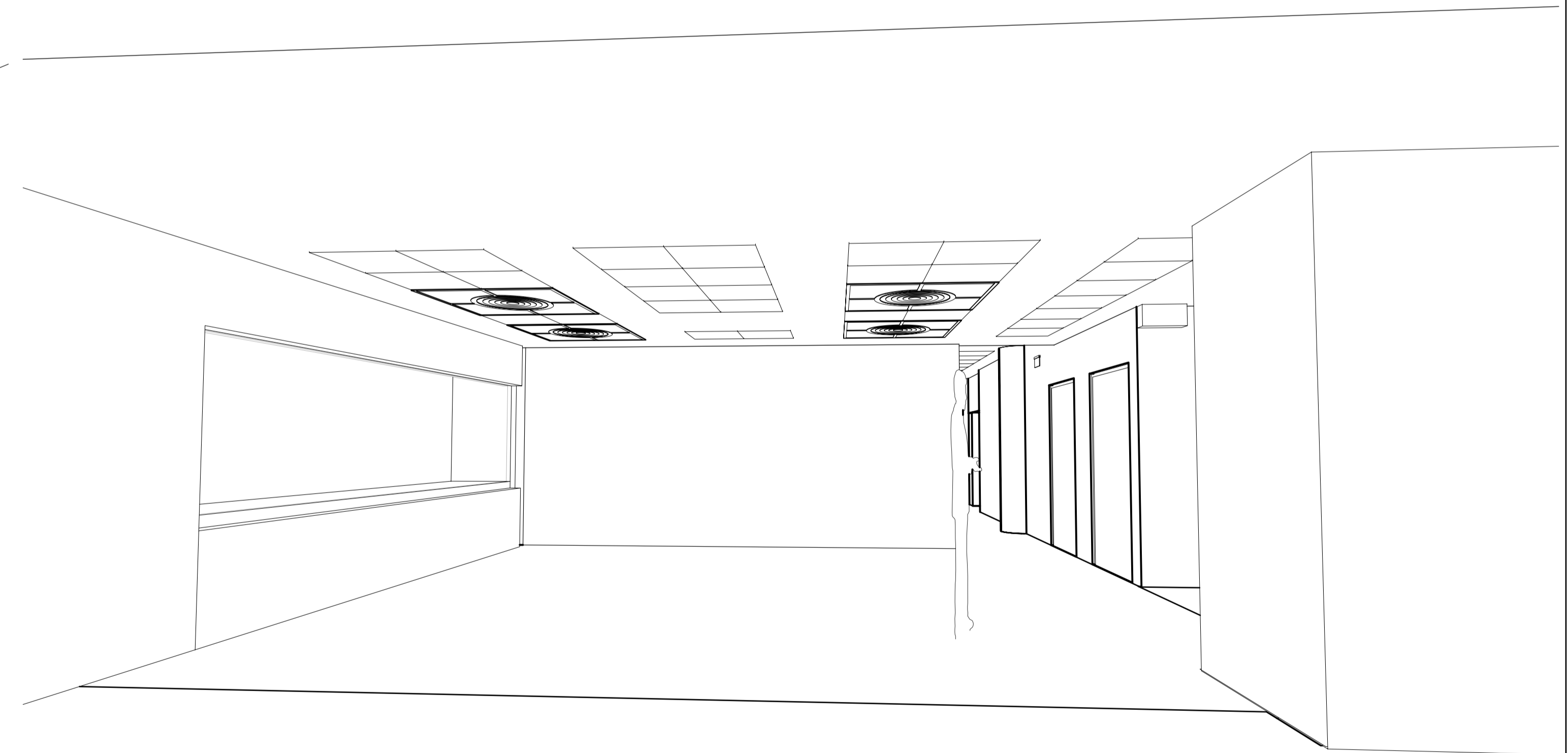
ENTRANCE VIEW LOOKING NORTH WEST TO PACCAR 2
